

FUND OBJECTIVE



FUND COMMENTARY ~ JULY 2020

The fund's gain during July was largely driven by the sale of a long standing top holding, Quantum Foods. We exited Quantum at 600c per share. This compares with a June month end price of 473c and a trading level in the mid 300's for much of the past few years. This value unlock as two competing investors built large stakes in the company was pleasing, and we believe there are several other undervalued small caps in the fund where corporate action could well occur, and release the value which investor aversion to small caps is creating.

We reinvested much of the proceeds into a Top 40 stock, British American Tobacco (BAT), taking advantage of the 15% pullback in the share price during the first three weeks of July. This has left BAT trading on a PE Ratio of just 7.7x (using analyst's consensus forecasts for 2020), and a very generous dividend yield of 8.6%. The cigarette industry is clearly not going to attract a premium rating, but at this price investors appear to be taking an extra ordinarily pessimistic view of the company's future prospects.

MARKET COMMENTARY

International

Global geopolitical tensions continue to rise. Following the imposition of the security law in Hong Kong, both the UK and Australia have offered a pathway to citizenship for Hong Kong residents. The US has now turned its sights on banning Chinese-owned social media app, TikTok. Despite US-China vitriol, China's economy continues to outperform those of the rest of the world and it is the only major economy expected to grow in 2020.

In Europe, a deal on the €750bn recovery fund was reached after concessions were made to the "Frugal Four" - Austria, Denmark, Netherlands and Sweden.

At Flagship, we continue to see a two-track economy. The mega cap tech stocks continue to report blockbuster results, which is in stark juxtaposition to the US economy overall, which shrank by 9.5% on a quarter-on-quarter basis in the second quarter (or 34.1% annualized). Apple, Amazon, Facebook and Google all reported results ahead of expectations with the 25% increase in iPhone sales reported by Apple and the 40% y-o-y increase in revenues reported by Amazon being the stand-outs. Regulatory concerns continue to be the largest risk for

these businesses, which is evident from the fact that all their CEOs were called to testify before Congress on anti-competitive concerns.

Last, but not least, gold is in sight of the \$2,000 per ounce mark as the dollar weakens on fears that large US budget deficits and endless money printing are debasing the currency.

South Africa

South Africa's hard lockdown continues. The ban on alcohol has been reinstated and the ban on tobacco continues – even though the cost to the fiscus has been billions of Rands in foregone taxes. It is also causing an enormous amount of damage to the wine (and associated) industries, which are large employers in the country. Despite Cyril Ramaphosa having committed to fighting corruption, new allegations in the awarding of Covid PPE tenders have emerged. The husband of his spokesperson has also been implicated. Of significant concern, this brings into question how amounts raised from multi-lateral development banks will be spent.

Investment Policy

The Flagship IP Flexible Value Fund is an asset allocation portfolio. The manager, in selecting securities for the portfolio, will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Flagship IP Flexible Value Fund, shall comprise a mix of securities, which may include ordinary shares, preference shares, debentures, fixed interest instruments, gilts and money market instruments as defined in the Act and the Deed, all to be acquired at a fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes or other similar schemes. Where the aforementioned schemes are operated in territories other than in South Africa, participatory interests or any other form of participation in these schemes will be included in the portfolio only where the regulatory environment is to the satisfaction of the manager and trustee and is of sufficient standard to provide investor protection at least equivalent to that in South Africa. TER and Transaction Costs

From 1 April 2017 to 31 March 2020, 1.68% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.29% of the value of the fund was incurred as costs relating to the administration of the fund. Inclusive in the TER of 1.68%, a performance fee of 0% of the Net Asset Value of the class of Financial Product was recovered.
