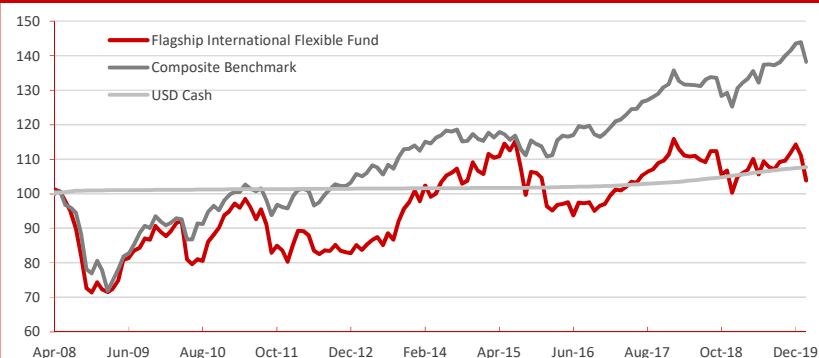

INVESTMENT OBJECTIVE

The Fund is a multi-asset, globally diversified portfolio investing in equities, bonds, property, and money market instruments without restriction. It does not impose target bands across any of these classes and may deviate materially from its benchmark (50% equities, 30% bonds, and 20% money market). We seek to achieve our investment objective of long-term capital growth with an acceptable level of risk through an actively-managed portfolio of assets, spread over a broad range of asset classes, currencies, and geographies in varying proportions over time. The fund should be viewed as a medium to long term investment.

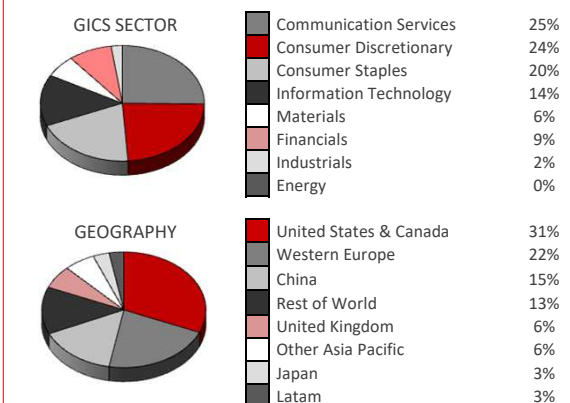

FUND MANAGER COMMENTARY - FEBRUARY 2020

In February, your fund contracted by 6.6%, while the fund's benchmark was down 3.9% and the MSCI All World Index declined 8.6%. The largest detractors were Walt Disney, Informa and Heineken. Despite the general weakness in markets, Endava managed to generate a positive return. Bonds and gold performed well. We have made the portfolio more robust to tail-risk scenarios by trimming positions in companies that are likely to be worse affected by the Coronavirus, adding to those that are more resilient, and increasing our cash and gold weightings.

INVESTMENT COMMENTARY

March has been the most eventful month for equities in a long time. The cause has been the global fallout from the Coronavirus. To date the number of those infected is over ninety thousand and the number of confirmed deaths over three thousand. While the virus was originally confined to Asia, we are beginning to see outbreaks in Europe, North America, and closer to home in Nigeria and Algeria. After its muted initial response, markets have started to price in a far more serious fall-out. In fact, during the last week in February, the decline in equity prices was the fastest correction in the S&P 500 on record (-12% in 6 days).

While, to paraphrase the words of Rudyard Kipling, we as investors "should keep our heads when all those about us are losing theirs", we also need to be alert to potential tail risk scenarios and the probability that those materialize. As such, we are monitoring developments closely.

The first order impacts of the Coronavirus were felt by companies who are in the travel industry or outdoor entertainment industries (Walt Disney, Informa).

Next affected have been those companies who have large direct supply chain exposure to China (Apple, Samsung) or companies that rely on the region for a large proportion of their sales (the luxury goods companies).

We are now beginning to see the effects spread more broadly as the revenues of all companies are a derivative of economic growth, to a lesser or greater extent.

TER

The Flagship International Flexible Fund Class A USD has a Total Expense Ratio (TER) of 2.01%. Financial year-end TER 2.00%. The Total Expense Ratios (TERs) are the percentages of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.
