

FUND OBJECTIVE

The objective of the Flagship IP Worldwide Flexible Fund of Funds is to deliver long term capital growth by investing in a focused portfolio of stringently selected global equity fund managers. Investments, on a see-through basis, will be diversified across geographic regions, in both developed and emerging markets, and diversifies single manager and single style risk associated with investing through one asset manager only. The fund may invest across all asset classes, but, through the cycle, equity exposure will be maintained at around 80%, with the objective to outperform the MSCI World Index (in rands) over the long term (5 years). Our formal benchmark is CPI +5% and the fund is classified in the Worldwide - Multi Asset - Flexible sector.

FUND COMMENTARY ~ APRIL 2020

The fund's 10.6% April return was markedly above its CPI +5% benchmark return for the month as global markets rallied off their March lows, but slightly underperformed the MSCI ACWI as the fund was only 80% invested. The fund has outperformed both its benchmark and the average fund in the ASISA multi-asset flexible category over 1, 3, 5, and 7 years, delivering 14.4% per annum after all fees since inception in April 2003.

Four of our seven equity funds outperformed or were broadly in line with the MSCI ACWI in April while three underperformed. The bulk of the underperforming funds follow value strategies which continue to underperform relative to funds which follow growth and quality strategies. That said, we believe it would be dangerous to extrapolate the current poor performance of value managers into the future and believe that value funds perform an important role in diversifying the fund's exposures.

MARKET COMMENTARY

International

Markets have bounced back quickly – as at 30 April, the S&P 500 was up almost 35% from its 23^{rd} March low. While this has been on the back of enormous fiscal and monetary stimulus, the speed and magnitude of the recovery has been disproportionate to the improvement in underlying economic fundamentals, which continue to be poor. In the six weeks to the end of April, 30 million people had sought unemployment benefits in the US and unemployment figures are on course to reach levels last seen in the Great Depression. A similar situation exists in Europe.

Most economists are now predicting a U-shaped recovery for the world economy (slow and gradual) as opposed to a speedy V-shaped recovery.

The most volatile corner of global markets in April was undoubtedly commodities markets, as WTI (the US benchmark blend for oil) traded negative prior to futures close out for the *first time ever*. This was over fears that oil supply would exceed physical storage capacity because, unlike other types of futures contracts, oil futures require traders to take physical delivery of oil.

The agreement reached between the OPEC+ alliance and the US earlier in the month to cut global production by 9.7mn barrels per day in May and June (almost 10 percent of global supply) has thus been insufficient to offset the decline in global oil demand. Oil prices continue to exhibit above average volatility.

South Africa

South Africa concluded its first full month of stage 5 lockdown, which ended on the 30th of April. To support the economy, the government announced a stimulus package of R500bn on the 21st of April. This included a R200bn loan guarantee for small businesses. Given South Africa's precarious fiscal position, the stimulus package was a sensible compromise between alleviating the negative impacts of the COVID 19 epidemic, whilst limiting the deterioration in its fiscal position, with the actual cost of this loan guarantee hopefully being far less than the headline number. Despite this, the JSE marginally underperformed developed markets over the month.

Investment Policy

The Flagship IP Worldwide Flexible Fund of Funds is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the portfolio is to offer medium to long-term capital growth. The portfolio will invest in a range of participatory interests in equity, bond, money or property markets, in portfolios of collective investment schemes.

In order to achieve its objective, the investments normally to be included in the Flagship IP Worldwide Flexible Fund of Funds will, apart from assets in liquid form, consist of participatory interests of portfolios of collective investment schemes or other similar schemes, in equity, bond, money or property markets, registered in the Republic of South Africa, or of portfolios of collective investment schemes or other similar schemes or other similar schemes or other satisfaction of the Manager and the Trustee, and comply with the requirements of the Act and any regulations thereto.

TER and Transaction Costs

From 1 January 2017 to 31 December 2019 2.40% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.58% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.98% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.

Fund Risk Profile

The investment philosophy is medium to long term in nature but with a conservative bias. The use of several managers diversifies the single-manager and single-style risk associated with investing through one asset manager only. Asset allocation is adjusted according to changes in market conditions.
