

FUND OBJECTIVE

The objective of the Flagship IP Worldwide Flexible Fund of Funds is to deliver long term capital growth by investing in a focused portfolio of stringently selected global equity fund managers. Investments, on a see-through basis, will be diversified across geographic regions, in both developed and emerging markets, and diversifies single manager and single style risk associated with investing through one asset manager only. The fund may invest across all asset classes, but, through the cycle, equity exposure will be maintained at around 80%, with the objective to outperform the MSCI World Index (in rands) over the long term (5 years). Our formal benchmark is CPI +5% and the fund is classified in the Worldwide - Multi Asset - Flexible sector.



FUND COMMENTARY - JULY 2020

The fund's July return of 2.7% outperformed its CPI +5% benchmark during the month, increasing its year-to-date return to +25.0%. The fund continues to outperform its benchmark over all meaningful periods.

Across the funds we like to see managers who are 1) focused on following one investment philosophy in a structure that allows them to do so, 2) do not stray from their investment mandate or process, 3) have meaningful skin in the game and 4) a track record of success. On top of this, the structures we invest through are unitised and tightly regulated by relevant European or UK authorities. Across all our funds, the management fees we have been able to negotiate are considerably lower than those that can be achieved by a retail investor. No fund is selected in isolation – we have created a portfolio of funds that complement one another based on where we believe we are in the cycle.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

Global geopolitical tensions continue to rise. Following the imposition of the security law in Hong Kong, both the UK and Australia have offered a pathway to citizenship for Hong Kong residents. The US has now turned its sights on banning Chinese-owned social media app, TikTok. Despite US-China vitriol, China's economy continues to outperform those of the rest of the world and it is the only major economy expected to grow in 2020.

In Europe, a deal on the €750bn recovery fund was reached after concessions were made to the "Frugal Four" - Austria, Denmark, Netherlands and Sweden.

At Flagship, we continue to see a two-track economy. The mega cap tech stocks continue to report blockbuster results, which is in stark juxtaposition to the US economy overall, which shrank by 9.5% on a quarter-on-quarter basis in the second quarter (or 34.1% annualized). Apple, Amazon, Facebook and Google all reported results ahead of expectations with the 25% increase in iPhone sales reported by Apple and the 40% y-o-y increase in revenues reported by Amazon being the stand-outs. Regulatory concerns continue to be the largest risk for

these businesses, which is evident from the fact that all their CEOs were called to testify before Congress on anti-competitive concerns.

Last, but not least, gold is in sight of the \$2,000 per ounce mark as the dollar weakens on fears that large US budget deficits and endless money printing are debasing the currency.

South Africa

South Africa's hard lockdown continues. The ban on alcohol has been reinstated and the ban on tobacco continues – even though the cost to the fiscus has been billions of Rands in foregone taxes. It is also causing an enormous amount of damage to the wine (and associated) industries, which are large employers in the country. Despite Cyril Ramaphosa having committed to fighting corruption, new allegations in the awarding of Covid PPE tenders have emerged. The husband of his spokesperson has also been implicated. Of significant concern, this brings into question how amounts raised from multi-lateral development banks will be spent.

Investment Policy

The Flagship IP Worldwide Flexible Fund of Funds is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the portfolio is to offer medium to long-term capital growth. The portfolio will invest in a range of participatory interests in equity, bond, money or property markets, in portfolios of collective investment schemes.

In order to achieve its objective, the investments normally to be included in the Flagship IP Worldwide Flexible Fund of Funds will, apart from assets in liquid form, consist of participatory interests of portfolios of collective investment schemes or other similar schemes, in equity, bond, money or property markets, registered in the Republic of South Africa, or of portfolios of collective investment schemes or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee, and comply with the requirements of the Act and any regulations thereto.

TER and Transaction Costs

From 1 April 2017 to 31 March 2020 2.40% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.56% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.96% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns.
