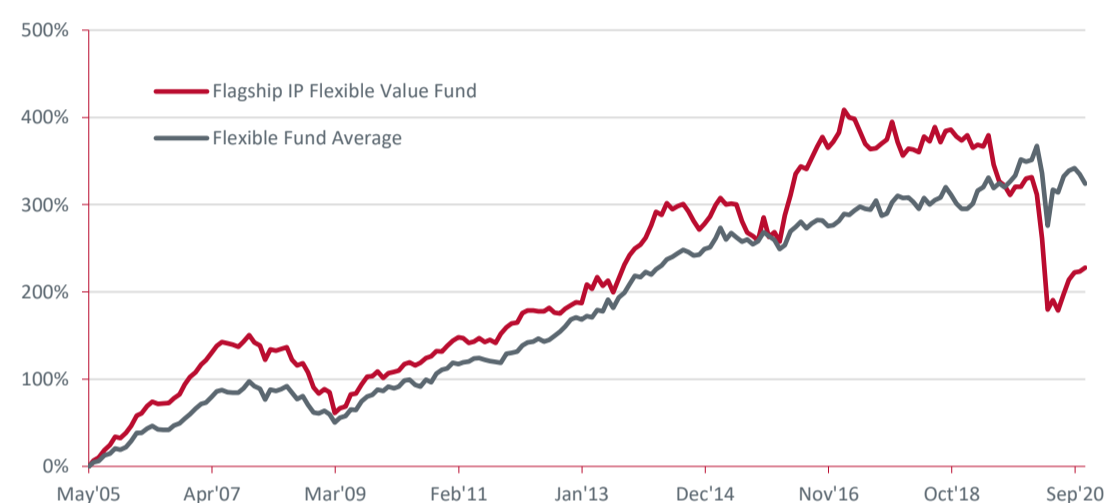

FUND OBJECTIVE

The Flagship IP Flexible Value Fund aims to outperform both the JSE All Share Index and competing funds over the medium to long term. We rely on fundamental research to identify investments which are trading at a discount to their intrinsic value and to determine which asset classes are the most attractive. The fund will typically have a very different equity profile from that of the All Share Index. Risk is reduced through the fund's value oriented approach.

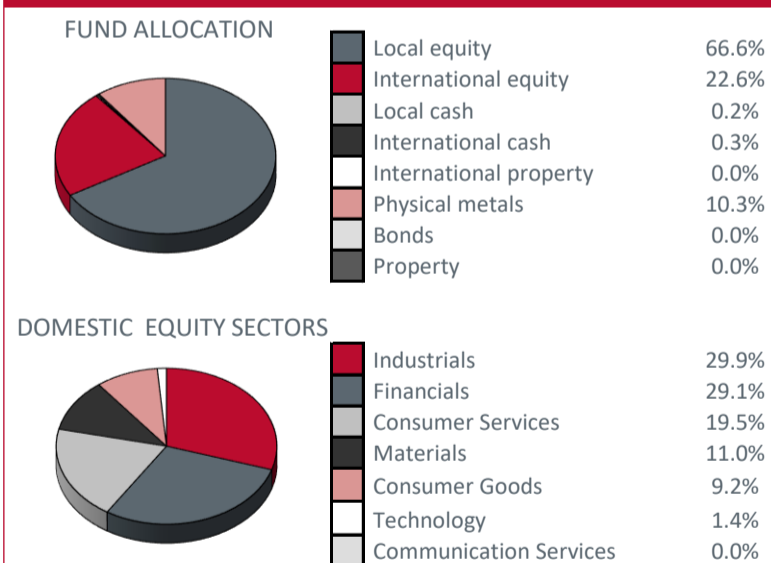

FUND COMMENTARY - OCTOBER 2020

The fund had a positive month gaining 1.4%. This compares favourably with the 4.7% fall in the JSE All Share Index. The only change in the top ten holdings is that Zeder is replaced by Hosken Passenger Logistics (HPL). The company's main asset is Golden Arrow Bus Services, not what most investors would regard as an exciting investment. Having said that, we believe that the investment case is compelling, notwithstanding the fact that this year's earnings will be down on last year's 90cps. The balance sheet is rock solid with R490m in cash at 31 March. This represents just over 50% of the company's market capitalisation: the strong balance sheet may well allow HPL to maintain last year's 45c annual dividend, placing the shares on a 15% dividend yield at the current R3 share price. Other positives are that the company is extremely efficiently run, provides an essential service, and is benefitting from the catastrophic state of the rail services in the Western Cape.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

The US election dominated October headlines, with voting to be held on November 3. By November 2, over 93 million Americans had already voted, equal to 58.6% of the total votes cast in the 2016 general election. High voter turnout is a sign of the anxiety and polarisation surrounding the election.

The election process has been predictably raucous, with social media companies making enormous efforts to prevent the spread of false news pertaining to the candidates. Predictions, for what they are worth, are for a Biden win.

The S&P 500 pared its gains in the month, leaving it up just 1.2% year-to-date. The final week of October also saw the Nasdaq lose 5.5%, but is still up a healthy +26% year-to-date. Over the next few weeks the markets will digest the winning candidate, or digest the fact that the incumbent may refuse to accept the results, as he has threatened.

U.K. and European Union officials continue to work on a solution to break the eight-month deadlock over one of the biggest obstacles to their planned trade deal. The British finance minister, Rishi Sunak, has warned colleagues that a second

lockdown has thrown the Government's ability to maintain current levels of spending on public services into doubt.

Oil plunged to a five-month low as Libya continued to ramp up crude production after a truce in its civil war, while a resurgent coronavirus prompted tighter lockdown measures in Europe.

South Africa

South Africa's medium-term budget speech was released in October. In it, the finance minister outlined plans to reduce government spending on wages, while also increasing hand-outs to SAA and selected other entities that have been impacted by the COVID pandemic. Moodys rating agency was not positive, saying the speech does not outline how and when the government will implement policies to boost growth and arrest the deterioration in public finances. They expect the economy will remain subdued, with little room for fiscal consolidation, and hence a sustained rise in government debt. The Rand ended the month down 13.9% year-to-date against the dollar and 17% against the Euro. The JSE All Share lost 4.7% in the month and is now down 7.1% year-to-date, which is -21% in dollars.

Investment Policy

The Flagship IP Flexible Value Fund is an asset allocation portfolio. The manager, in selecting securities for the portfolio, will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Flagship IP Flexible Value Fund, shall comprise a mix of securities, which may include ordinary shares, preference shares, debentures, fixed interest instruments, gilts and money market instruments as defined in the Act and the Deed, all to be acquired at a fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes or other similar schemes. Where the aforementioned schemes are operated in territories other than in South Africa, participatory interests or any other form of participation in these schemes will be included in the portfolio only where the regulatory environment is to the satisfaction of the manager and trustee and is of sufficient standard to provide investor protection at least equivalent to that in South Africa. The portfolio is permitted to invest in financial instruments in line with the conditions by the Registrar from time to time.

TER and Transaction Costs

From 1 July 2017 to 30 June 2020, 1.69% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.37% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore 1.96% of the value of the fund was incurred as costs relating to the investment of the fund. Inclusive in the TER of 1.69%, a performance fee of 0% of the Net Asset Value of the date of Financial Product was recovered. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns.
