

FUND OBJECTIVE

The objective of the Flagship IP Balanced Fund is to seek steady growth of both capital and income through investments in a broad range of asset classes in a balanced manner. This Regulation 28 managed fund is classified as South African - Multi Asset - High Equity and aims to maximize returns over the medium to long term utilising flexible asset allocation strategies taking active decisions in accordance with current and projected economic and market conditions. The fund invests in equities, bonds, property and money market and is restricted to maximum limits in accordance with prudential regulations which, inter alia, provide that equity, held both locally and abroad, will not exceed 75% of the fund and offshore investment is restricted to 30% of the fund. Out-performance is targeted through aggressive asset allocation and focused stock selection based on in-house proprietary models and extensive internal and external research. The portfolio uses financial instruments only to the extent permitted by legislation.



FUND COMMENTARY - JANUARY 2021

A solid start to the year, with the fund up +4.4%, well ahead of the sector bechmark of +2.8%. The 12 month return of +16.6% is also pleasing as it exceeds the sector return of +3.9% by a healthy margin.

There were some very strong gains from a few of the fund's Top 10 holdings: Naspers +15.2%, Prosus +9.2%, Tencent +20.8%, Cartrack +54.4%, and Sasol +23.6%. Negative influences on the portfolio were the stronger rand and the full write down of the fund's holding in Comair which, frustratingly, is exiting business rescue with no value attributable to the previous shareholders. As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

The MSCI All Country World Index returned 0.1% for the month in USD and 3.4% in ZAR. Emerging Markets stocks and the Nasdaq both outperformed this, returning 5.0% and 1.7% in USD respectively. The oil price climbed 9.4% for the month (now at \$56 per barrel), up 48% over the past three months.

The first deliveries of vaccines and the trading fiasco at GameStop dominated January headlines. Smaller nations like Israel, Bahrain and the UAE have predictably done better in delivering vaccines, while the rollout in the UK and Europe has been problematic. We note that U.S. vaccination progress is leading to rapidly falling new cases and hospitalization data. This will continue, and we celebrate both the efforts of medical teams around the world to immunize the vulnerable, as well as a significantly improving economic outlook for the second half of the year.

Of most interest were the GameStop headlines. The trading frenzy in GameStop shares over the past week has not only provided grand theatre, but also a pertinent lesson in market price formation and risk management. Already, the results of the GameStop short squeeze have raised questions about market efficiency, regulation and financial stability, and it is clear that, notwithstanding Trump having left office with a blocked Twitter account, social media has not lost its influence on markets.

South Africa

South African equities returned 5.5% in ZAR in January. While local equities got off to a strong start, the SA index has underperformed emerging market peers by 19% over the past 12 months, to say nothing of developed market peers. It has become clear that the risks facing South Africa are now well understood by market participants, with the MSCI SA multiple (10.9x) now at a 32% discount to emerging markets.

Despite the government's best efforts to foil it, the economy continues to try and resuscitate itself. Unsurprisingly, the President's plan of fighting the pandemic, corruption and a financial disaster with words and posturing have not borne fruit, and have instead exposed how hollowed out the capabilities of the state have become. In the words of Exxaro's frustrated CEO: "what is now needed urgently is decisive action from the president. Words and vague intentions simply do not cut it". The President will appear appropriately shocked.

Elsewhere, a much-needed prosecution of former president Jacob Zuma continues to be gobsmackingly out of reach, with the organs of State unable to act on his clear disregard for the law of the land. Should he not be prosecuted, it would send a clear signal that South Africa has "neither a political nor economic environment for investment in the country", according to Business Unity SA president Sipho Pityana. We agree.

Investment Policy

The Flagship IP Balanced Fund is to be a domestic, asset-allocation, prudential variable portfolio. The primary objective of the fund is to seek steady but stable growth of both capital and income through investments in a broad range of asset classes in a balanced manner. In order to achieve its objective, the investments normally to be included will comprise a combination of securities in the equity, bond, property and money markets. The portfolio will have an equity exposure (including international equity) between 0% and 75% at all times. Investments to be included in the Flagship IP Balanced Fund will comprise a combination of securities and assets in liquid form which are considered consistent with the portfolio's primary objective and that the Act or the Registrar may from time allow, all to be acquired at fair market value. The portfolio may also include participatory interests or any other form of participation in portfolio of collective investment schemes registered in South Africa or operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee and as legislation permits. Nothing contained in the investment policy shall preclude the manager from varying the ratio of the aforementioned securities relative to each other (except as required by the Act), or the assets themselves, to maximise capital growth and investment potential, should changing economic factors or market conditions so demand. Provided also that nothing contained in the investment policy shall preclude the Manager from retaining cash in the portfolio and / or placing cash on deposit in terms of the deed. Provided further that the Manager shall ensure that the portfolio includes securities and assets in liquid form, of at least the aggregate value required, from time to time, by the Act. The Manager will be permitted to invest on behalf of the portfolio in financial instruments as legislation permits. TER and Transaction Costs

From 1 October 2017 to 30 September 2020 2.43% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.31% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.74% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns.
