

FUND OBJECTIVE

The Flagship IP Flexible Value Fund aims to outperform both the JSE All Share Index and competing funds over the medium to long term. We rely on fundamental research to identify investments which are trading at a discount to their intrinsic value and to determine which asset classes are the most attractive. The fund will typically have a very different equity profile from that of the All Share Index. Risk is reduced through the fund's value oriented approach.

FUND COMMENTARY ~ MARCH 2021

The fund gained 5.3% in March and is up 18% for the first quarter – a good start to the year as small cap value stocks continued to regain favour with investors after many years in the wilderness. This is a global trend which the JSE is following. March's strong showing was primarily driven by gains in selected domestic stocks, while our offshore equities advanced modestly after an extraordinarily strong January and February. We did lock in some gains offshore, and this has increased the fund's cash weighting from a negligible amount to 5.8% - mostly in USD. As indicated in the top ten holdings above, there have been no changes since last month and we remain focussed on small caps; although some, such as Nampak, were certainly not small caps in their heyday! A recent JP Morgan report on small and mid caps globally could not be more bullish. They expect this asset class to "dwarf" the returns of most other asset classes for decades to come! They cite numerous factors including the valuation disparity relative to large caps, faster earnings growth over time, companies that are relatively shielded from protection and populism, a history of out-performance when interest rates are rising and several more besides. Even if they are only half right, a high weighting such as we have in this sub-sector of the market will prove very rewarding, subject, of course, to picking the right stocks. As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

The light at the end of the pandemic tunnel is starting to get brighter. The first quarter of 2021 has ushered in renewed hope of a broad-based recovery across most developed markets. Stock markets have – unsurprisingly - reacted favourably to the positive macroeconomic data, and all global indices are up year-to-date. The MSCI All Country World index, a barometer of global stock markets, has risen +5.2% in USD (+5.6% in ZAR) year-to-date, and over +61.3% in USD (+31.2% in ZAR) over the past twelve months.

Equity valuations remain elevated, with the 12-month forward priceearnings-ratio (or P/E ratio) of the S&P 500 at 23x at the time of writing versus its 30-year average of 17.3x. We have noted that as earnings expectations have increased for 2021, the P/E ratio has declined as share prices have moved sideways in recent months

Inflation expectations have ticked up. The advent of inflation - and the monetary tightening that follows it - has traditionally been the destroyer of bull markets, so it's logical that market participants would worry about it. Oil (+25% year-to-date) and copper (+16%) are driving inflation, as well as benefitting from it through investor safe haven status.

Stimulus, and the increasing impact of both passive funds and retail investors, are playing a larger role in asset markets. In US equities, passive funds are now roughly as large as the actively managed investment universe after a decade of rampant growth, while retail investors now account for nearly as much as all mutual and hedge fund trading combined.

South Africa

The JSE All Share Index delivered a return of +1.6% in Rands and a +4.4% return in dollars. Despite large gains in the last few months, the JSE has returned a miserly +2.4% per annum in USD over ten year versus +9.7% per annum for the MSCI ACWI. This translates to a total 10-year return of +456.3% over ten years for the MSCI ACWI versus +180.6% for the JSE, both in 7AR

Vaccine deployment continues at a snail's pace, as do investigations into state capture. Consumers face two massive hits from this month: the first being Eskom's decision to increase electricity tariffs by 15.6% on 1 April 2021, and the second, an increase in the petrol price by as much as R1 a litre, and diesel by 66c. This implies that fuel will now cost R17.32 a litre, comfortably surpassing the previous high of R17.08 set in late 2018.

Investment Policy

The Flagship IP Flexible Value Fund is an asset allocation portfolio. The manager, in selecting securities for the portfolio, will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Flagship IP Flexible Value Fund, shall comprise a mix of securities, which may include ordinary shares, preference shares, debentures, fixed interest instruments, gilts and money market instruments as defined in the Act and the Deed, all to be acquired at fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes or other similar schemes. Where the aforementies and other form of participation in these schemes will be included in the portfolio only where the regulatory environment is to the satisfaction of the manager and trustee and is of sufficient standard to provide investor protection at least equivalent to that in South Africa. The portfolio is permitted to invest in financial instruments in line with the conditions by the Registrar from time to time.
