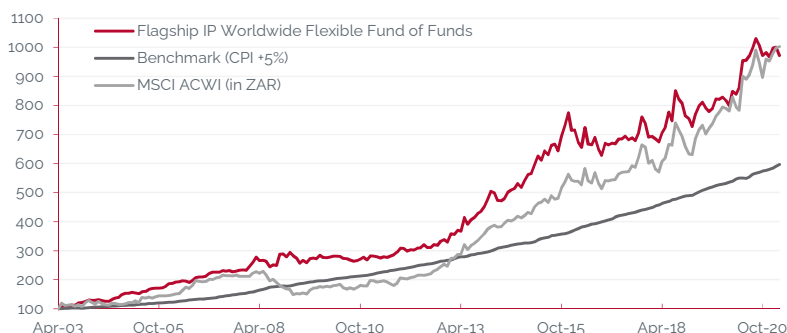

FUND OBJECTIVE

The objective of the Flagship IP Worldwide Flexible Fund of Funds is to deliver long term capital growth by investing in a focused portfolio of stringently selected global equity fund managers. Investments, on a see-through basis, will be diversified across geographic regions, in both developed and emerging markets, and diversifies single manager and single style risk associated with investing through one asset manager only. The fund may invest across all asset classes, but, through the cycle, equity exposure will be maintained at around 80%, with the objective to outperform the MSCI World Index (in rands) over the long term (5 years). Our formal benchmark is CPI +5% and the fund is classified in the Worldwide - Multi Asset - Flexible sector.

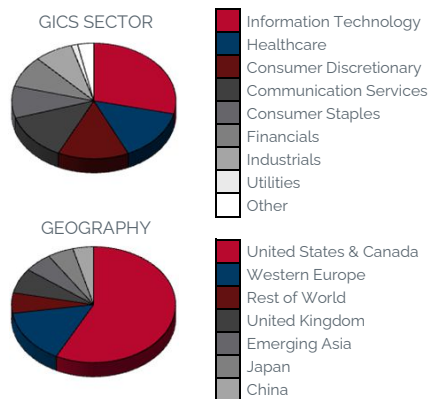

FUND COMMENTARY - MARCH 2021

Your fund returned -2.9% for the month in Rands versus the MSCI ACWI which delivered a return of +0.5% (in ZAR). Your fund's "alpha" (return exceeding its CPI +5% benchmark return) over 12 months is +4.5%. For the month, the fund's largest contributors were the iShares MSCI ACWI ETF and Mondrian. The largest detractors were Sands Capital and Artisan Global Discovery.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

The light at the end of the pandemic tunnel is starting to get brighter. The first quarter of 2021 has ushered in renewed hope of a broad-based recovery across most developed markets. Stock markets have – unsurprisingly – reacted favourably to the positive macroeconomic data, and all global indices are up year-to-date. The MSCI All Country World index, a barometer of global stock markets, has risen +5.2% in USD (+5.6% in ZAR) year-to-date, and over +61.3% in USD (+31.2% in ZAR) over the past twelve months.

Equity valuations remain elevated, with the 12-month forward price-earnings-ratio (or P/E ratio) of the S&P 500 at 23x at the time of writing versus its 30-year average of 17.3x. We have noted that as earnings expectations have increased for 2021, the P/E ratio has declined as share prices have moved sideways in recent months.

Inflation expectations have ticked up. The advent of inflation – and the monetary tightening that follows it – has traditionally been the destroyer of bull markets, so it's logical that market participants would worry about it. Oil (+25% year-to-date) and copper (+16%) are driving inflation, as well as benefitting from it through investor safe haven status.

Stimulus, and the increasing impact of both passive funds and retail investors, are playing a larger role in asset markets. In US equities, passive funds are now roughly as large as the actively managed investment universe after a decade of rampant growth, while retail investors now account for nearly as much as all mutual and hedge fund trading combined.

South Africa

The JSE All Share Index delivered a return of +1.6% in Rands and a +4.4% return in dollars. Despite large gains in the last few months, the JSE has returned a miserly +2.4% per annum in USD over ten year versus +9.7% per annum for the MSCI ACWI. This translates to a total 10-year return of +456.3% over ten years for the MSCI ACWI versus +180.6% for the JSE, both in ZAR.

Vaccine deployment continues at a snail's pace, as do investigations into state capture. Consumers face two massive hits from this month: the first being Eskom's decision to increase electricity tariffs by 15.6% on 1 April 2021, and the second, an increase in the petrol price by as much as R1 a litre, and diesel by 66c. This implies that fuel will now cost R17.32 a litre, comfortably surpassing the previous high of R17.08 set in late 2018.

- SARS requires us to pay over Dividend Withholding Tax (DWT) on your behalf where applicable. We will deduct this tax before we pay any dividends to you or reinvest into your account. Unless we receive information from you indicating otherwise, we will be obliged to withhold the default DWT of 20%.

Investment Policy

The Flagship IP Worldwide Flexible Fund of Funds is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the portfolio is to offer medium to long-term capital growth. The portfolio will invest in a range of participatory interests in equity, bond, money or property markets, in portfolios of collective investment schemes.

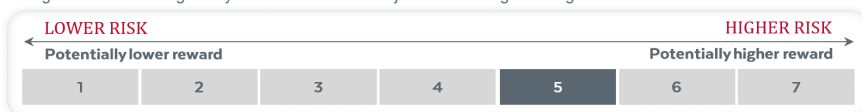
In order to achieve its objective, the investments normally to be included in the Flagship IP Worldwide Flexible Fund of Funds will, apart from assets in liquid form, consist of participatory interests of portfolios of collective investment schemes or other similar schemes, in equity, bond, money or property markets, registered in the Republic of South Africa, or of portfolios of collective investment schemes or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee, and comply with the requirements of the Act and any regulations thereto.

TER and Transaction Costs

From 1 January 2018 to 31 December 2020 2.39% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.31% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.70% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.
