

FUND OBJECTIVE

The objective of the Flagship IP Worldwide Flexible Fund of Funds is to deliver long term capital growth by investing in a focused portfolio of stringently selected global equity fund managers. Investments, on a see-through basis, will be diversified across geographic regions, in both developed and emerging markets, and diversifies single manager and single style risk associated with investing through one asset manager only. The fund may invest across all asset classes, but, through the cycle, equity exposure will be maintained at around 80%, with the objective to outperform the MSCI World Index (in rands) over the long term (5 years). Our formal benchmark is CPI +5% and the fund is classified in the Worldwide - Multi Asset - Flexible sector.

FUND COMMENTARY - APRIL 2021

For the month of April, the Flagship IP Worldwide Flexible Fund of Funds delivered a return of 2.7% in Rands, comfortably exceeding its CPI plus 5% benchmark.


The return of all the Funds in which we are invested exceeded that of the MSCI ACWI. The best performing funds were Artisan Global Discovery and Guinness Global Innovators, with Lindsell Train and GQG the relative laggards.

MARKET COMMENTARY

International

Whilst equity markets continue to perform well, the global recovery from Covid is taking place in an uneven fashion. This threatens to widen the disparity between the "haves" and the "have nots" even further. The "haves" are most of the developed world – where vaccination programmes are proceeding according to plan and where lockdowns are gradually easing – and, of course, China. The Chinese economy grew 18.3% y-o-y in the first quarter, its highest print ever.

In parts of the developing world, things appear far less rosy. This is perhaps most starkly evident in India where record numbers of new infections have brought its healthcare system to the point of collapse. India's allies are assisting, where they can, to avert disaster.

Taxes have moved to the centre of the global agenda as countries seek ways to fund their stimulus programmes. On the corporate income tax front, the US has proposed a global minimum tax rate as well as a system of taxing the profits of multinationals according to where they derive sales. The latter measure will affect the large tech names who have used elaborate transfer-pricing mechanisms to avoid paying tax.

Personal income tax rates are also likely to rise in the US. The US is seeking to raise the top marginal tax rate for the wealthy and to make them pay tax at the same rate on capital gains as they do on income.

While they may be facing rising taxes, in all other respects things are going well for the large tech names, all of which reported revenues and earnings which significantly exceeded expectations. This benefitted Flagship's global funds, which hold large positions in Microsoft, Facebook and Amazon.

South Africa

Newsflow in South Africa continues to be dominated by testimonies at the Zondo commission. Cyril Ramaphosa took the stand on the 28th of April where he admitted that the ANC had been weakened by corruption. His candour was in stark contrast to many of the other testimonies, which varied from the implausible to the absurd. The rand continues to perform well and strong commodity prices are contributing to both trade surpluses and budget deficits surprising on the upside. Longer-term, however, much remains to be done to put South Africa on a sustainable growth path.

Unless we receive information from you indicating otherwise, we will be obliged to withhold the default DWT of 20%.

Investment Policy

The Flagship IP Worldwide Flexible Fund of Funds is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the portfolio is to offer medium to long-term capital growth. The portfolio will invest in a range of participatory interests in equity, bond, money or property markets, in portfolios of collective investment schemes.

In order to achieve its objective, the investments normally to be included in the Flagship IP Worldwide Flexible Fund of Funds will, apart from assets in liquid form, consist of participatory interests of portfolios of collective investment schemes or other similar schemes, in equity, bond, money or property markets, registered in the Republic of South Africa, or of portfolios of collective investment schemes or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee, and comply with the requirements of the Act and any regulations thereto.

TER and Transaction Costs

From 1 January 2018 to 31 December 2020 2.39% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.31% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.70% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.

Fund Risk Profile

- The investment philosophy is medium to long term in nature but with a conservative bias. The use of several managers diversifies the single-manager and single-style risk associated with investing through one asset manager only. Asset allocation is adjusted according to changes in market conditions.
