

FUND OBJECTIVE

To provide long term capital growth from an actively managed portfolio comprising equities, bonds, listed property and cash – both local and foreign. To achieve long term capital growth, the fund will have a bias towards equity (which typically offers the best returns over the long run), but no guidelines have been set for maximum and minimum exposures to any one asset class. Our benchmark is 60% equities, 20% bonds and 20% cash with each category split equally between local and international assets. The fund is classified with ASISA as a Worldwide - Multi Asset - Flexible fund.



FUND COMMENTARY - JUNE 2021

Your Fund returned +5.7% (in ZAR) for the month versus its composite which delivered a return of +1.7%. During the month we saw both "growth" stocks recover some of their YTD underperformance relative to "value" stocks as well as domestic stocks recover some of their YTD underperformance relative to global stocks. The largest contributors were TCS, Zalando and Pagseguro. (We have profiled both TCS and Zalando in previous Flagship Telescope commentaries and will be profiling Pagseguro in this quarter's Telescope). The largest detractors were Gold, Netease and Antofagasta.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

Expectations for higher inflation were confirmed by higher inflation prints in June. US inflation rose to 4.7% y-o-y and core inflation rose to 3.2%. A debate is forming around the extent to which this is sustainable due to last year's low (Covid-induced) base. The Fed is positioned on the dovish side while markets are positioned on the hawkish side (evidenced by the degree to which break-even inflation rates have risen this year).

US big tech continues to be dogged by anti-trust concerns globally. Germany has launched an investigation into Apple's dominance and the EU (more broadly) launched an investigation into the market dominance of Alphabet's advertising business. While it is unquestionable that these businesses have formidable market positions, it is not a given that regulators need to intervene to curb their dominance. This was illustrated by a US judge finding in favour of Facebook in two cases brought against the company by the US Federal Trade Commission.

Bitcoin is languishing at or near the lows that were set in May. Regulators are seeking to assert their jurisdiction over the crypto market with the Chinese government clamping down on Bitcoin mining and UK regulators banning Chinese crypto exchange "Binance" from operating in the UK market.

Regulatory risks around cryptos should not be dismissed since they deprive governments of their seigniorage privileges.

This year has seen "value" stocks recover some of their underperformance relative to "growth" stocks, but June saw "growth" stocks make a come-back. Your funds hold larger positions in the latter than in the former, though we do not attach much value to either moniker. Shares will ultimately be valued at the net present value of their future cash flows, regardless of what optic multiples they trade on.

South Africa

Positive news abounded in June. Initially it was the announcement that the self-generation threshold for electricity would be raised to 100 MW. This was followed by the announcement that a controlling stake in SAA would be sold to a private shareholder. And, finally, the Constitutional Court declared that Zuma had been given a 15 month jail sentence for contempt of court after failing to appear before the Zondo commission as instructed. However, the positive feed through on asset prices that one would have expected from these developments, failed to materialize. The ZAR weakened against the USD and the MSCI South Africa gave up all its gains relative to the MSCI emerging markets over the last 12 months.

Investment Policy

The Flagship IP Worldwide Flexible Fund is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector which invests at least 15% of its assets in South African investment markets and no more than 85% of its assets in approved foreign investment markets, at all times, with specific focus on asset allocation. The primary objective of the Flagship IP Worldwide Flexible Fund is to offer medium to long-term capital growth. The portfolio will invest in a flexible combination of investments in equity, bond, money or property markets to maximise total returns over the long term. The portfolio will be actively managed with exposure to various asset classes being varied to reflect changing economic and market circumstances, in order to maximise returns for investors.

In order to achieve its objective, the investments normally included in the Flagship IP Worldwide Flexible Fund will comprise a combination of local and foreign securities, exchange securities, stock including loan stock, financially sound listed property investments and participatory interests in portfolios of collective investment schemes in property shares, assets in liquid form and any other securities which are considered consistent with the portfolio's primary objective and the Act or the Registrar may from time to time allow, all to be acquired at fair market value. To the extent permitted by legislation, the fund may use exchange traded funds and financial instruments to implement specific investment views.

TER and Transaction Costs

From 1 April 2018 to 31 March 2021 2.16% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.61% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.77% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.
