

FUND OBJECTIVE

The objective of the Flagship IP Balanced Fund is to seek steady growth of both capital and income through investments in a broad range of asset classes in a balanced manner. This Regulation 28 managed fund is classified as South African - Multi Asset - High Equity and aims to maximize returns over the medium to long term utilising flexible asset allocation strategies taking active decisions in accordance with current and projected economic and market conditions. The fund invests in equities, bonds, property and money market and is restricted to maximum limits in accordance with prudential regulations which, inter alia, provide that equity, held both locally and abroad, will not exceed 75% of the fund and offshore investment is restricted to 30% of the fund. Out-performance is targeted through aggressive asset allocation and focused stock selection based on in-house proprietary models and extensive internal and external research. The portfolio uses financial instruments only to the extent permitted by legislation.



FUND COMMENTARY ~ AUGUST 2021

In a month where most of the fund's large holdings took a severe beating, it is surprising that we were able to eke out a small gain of +0.3%. The JSE Materials sector fell -5.0% in August, and large fund holdings Implats (-15.6%), Northams (-13.4%), and Sibanye (-7.7%) contributed to the sector loss.

Fortuitously, the fund's fairly diverse equity holdings, coupled with our investments in fairly stable structured products and South African bonds, resulted in the small monthly gain.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

Internationa

August was a strong month for most global stock indices, with the S&P 500 up 3% for the month. Most commodity prices, with the exception of gold, weakened slightly during the month even though they remain up strongly for the year. The negative correlation between commodities and the dollar remains intact, as the US dollar appreciated slightly against most major currencies during the month although, it must be said, the dollar continued to weaken against the rand.

There have been a number of developments which have caused investors to reassess Chinese regulatory risk upwards. This began with the withdrawal of ANT's (an associate of Alibaba) IPO last year and has continued with, amongst other things, an investigation into anti-competitive practices of its tech titans; as well as a ban on after school tutoring; additional restrictions on computer gaming amongst children; and pressure being applied on corporates to make donations to social causes. This has resulted in a broadbased sell-off of Chinese stocks (-12.3% year-to-date). While enhanced monitoring of regulatory risk within China is paramount, we continue to believe that China is an attractive investment destination. Consequently, in our view, the fall in share prices of Chinese stocks more than compensates for the increase in regulatory risk.

Elsewhere in the world, the withdrawal of the US from Afghanistan on August 30th took centre stage, having been involved in conflict in the country for twenty years. While the move has attracted widespread criticism, it is worth noting that the US has spent an estimated \$2 trillion on the war and experienced 6,500 casualties, with little lasting progress having been made.

South Africa

Following the chaotic developments of last month, news out of South Africa was relatively muted.

Cyril Ramaphosa announced sweeping changes to his cabinet on August 5th although it was (in our opinion, correctly) viewed as a missed opportunity for him to remove certain serial underperforming members. Former Minister of Defence, Nosiviwe Mapisa-Nqakula, who attracted criticism for the way she handled last month's riots, effectively received a promotion – as the Speaker of Parliament she will earn more than she did previously as a minister.

Jacob Zuma succeeded in having himself removed from Estcourt Prison to hospital on medical grounds, although he has subsequently refused to subject himself to a Con Court ordered examination by the NPA doctors.

Investment Policy

The Flagship IP Balanced Fund is to be a domestic, asset-allocation, prudential variable portfolio. The primary objective of the fund is to seek steady but stable growth of both capital and income through investments in a broad range of asset classes in a balanced manner. In order to achieve its objective, the investments normally to be included will comprise a combination of securities in the equity, bond, property and money markets. The portfolio will have an equity exposure (including international equity) between 0% and 75% at all times. Investments to be included in the Flagship IP Balanced Fund will comprise a combination of securities and assets in liquid form which are considered consistent with the portfolio's primary objective and that he Act or the Registrar may from time allow, all to be acquired at fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes registered in South Africa or operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee and as legislation permits. Nothing contained in the investment policy shall preclude the manager from varying the ratio of the aforementioned securities relative to each other (except as required by the Act), or the assets themselves, to maximise capital growth and investment potential, should changing economic factors or market conditions so demand. Provided also that nothing contained in the investment policy shall preclude the Manager from retaining cash in the portfolio and / or placing cash on deposit in terms of the deed. Provided further that the Manager shall ensure that the portfolio includes securities and assets in liquid form, of at least the aggregate value required, from time to time, by the Act. The Manager will be permitted to invest on behalf of the portfolio in financial instruments as legislation permits. The portfolio will be managed so as to comply with prudential requirements with which

TER and Transaction Costs

From 1 July 2018 to 30 June 2021 2.39% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.28% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.67% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns.
