

FUND OBJECTIVE


The objective of the Flagship IP Worldwide Flexible Fund of Funds is to deliver long term capital growth by investing in a focused portfolio of stringently selected global equity fund managers. Investments, on a see-through basis, will be diversified across geographic regions, in both developed and emerging markets, and diversifies single manager and single style risk associated with investing through one asset manager only. The fund may invest across all asset classes, but, through the cycle, equity exposure will be maintained at around 80%, with the objective to outperform the MSCI World Index (in rands) over the long term (5 years). Our formal benchmark is CPI +5% and the fund is classified in the Worldwide - Multi Asset - Flexible sector.

FUND COMMENTARY ~ DECEMBER 2021

ANNUAL FUND PERFORMANCE

The Flagship IP Worldwide Flexible Fund of Funds returned -0.5% in ZAR over the month, behind the fund's CPI +5% benchmark. For the year, however, the fund's pleasing +17.0% return was well ahead of the benchmark's +10.8% return.

For the month, the largest contributor was Guinness Global. The iShares MSCI Value also put in a good showing as "value" stocks outperformed "growth" stocks. The largest detractors were Sands Capital (which has been a long-term winner) as well as Artisan Global Discovery.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

2021 was a great year for risk assets. The MSCI ACWI was up 19% for the year and both oil and copper rallied, up 50% and 29% respectively. However, due to rising inflation expectations, bonds performed poorly and gold closed the year down 4%.

Some very interesting dynamics took place beneath the headline numbers. If one looks at US stocks, which account for the bulk of our benchmark, just five stocks (Apple, Microsoft, Nvidia, Tesla and Alphabet) accounted for more than 50% of the S&P 500 returns since April, while hundreds of companies were trading at their lowest levels over the last 12 months. EM stocks, which retreated by 2%, also continued to underperform developed world stocks by a wide margin.

Geopolitical tensions ratcheted higher over the Russian troop build-up near Ukraine while the emergence of the Omicron COVID-19 variant created significant volatility across most markets and asset classes earlier in the month. But equities were able to shake off fears of the fast-spreading, less virulent variant and December saw strong gains led by the US (MSCI World +4.0%, S&P +4.4%).

Investors increased their expectations of a Fed hike as the FOMC announced a faster tapering schedule; US 2-year yields rose 17bps to 0.73%. However, the dollar weakened with DXY down 0.3% and EM FX up 0.7%. Economic momentum slowed slightly with key Economic Surprise Indices down in December in Europe (hard hit by Omicron) and China but up in the US. In commodities, Brent crude rebounded 11% to close the year at US\$77.46, its highest year-end close since 2013.

South Africa

The JSE ALSI had an excellent 2021, rallying 24% in ZAR. As the rand weakened by 8% against the USD, this meant the JSE delivered a 21% return in US dollars for the year, marginally ahead of the MSCI ACWI. Notwithstanding this good 1-year performance, it continues to be a laggard over longer periods. An issue to be aware of in 2022, is whether Ramaphosa will be re-elected as president of the ANC in its national elective conference in December. This will determine whether or not he is eligible to run for president in 2024's national election.

Investment Policy

The Flagship IP Worldwide Flexible Fund of Funds is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the portfolio is to offer medium to long-term capital growth. The portfolio will invest in a range of participatory interests in equity, bond, money or property markets, in portfolios of collective investment schemes.

In order to achieve its objective, the investments normally to be included in the Flagship IP Worldwide Flexible Fund of Funds will, apart from assets in liquid form, consist of participatory interests of portfolios of collective investment schemes or other similar schemes, in equity, bond, money or property markets, registered in the Republic of South Africa, or of portfolios of collective investment schemes or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee, and comply with the requirements of the Act and any regulations thereto.

TER and Transaction Costs

From 1 October 2018 to 30 September 2021 2.17% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.18% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.35% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.
