

FUND OBJECTIVE

The objective of the Flagship IP Worldwide Flexible Fund of Funds is to deliver long term capital growth by investing in a focused portfolio of stringently selected global equity fund managers. Investments, on a see-through basis, will be diversified across geographic regions, in both developed and emerging markets, and diversifies single manager and single style risk associated with investing through one asset manager only. The fund may invest across all asset classes, but, through the cycle, equity exposure will be maintained at around 80%, with the objective to outperform the MSCI World Index (in rands) over the long term (5 years). Our formal benchmark is CPI +5% and the fund is classified in the Worldwide - Multi Asset - Flexible sector.



FUND COMMENTARY - JANUARY 2022

The Flagship IP Worldwide Flexible Fund of Funds returned -6.4% in USD, and with the ZAR strengthening +3.5% led to a -10.7% ZAR monthly return as volatility shook global markets. The S&P 500 and the Nasdaq fell -8.1% and -12% in ZAR respectively.

The largest contributors to performance were the iShares MSCI Value and GQG Partners. The largest detractors were Sands Capital Global Growth and Artisan Global Discovery. The fund currently has a 79% weighting to equities with the balance in cash. We stand ready to apply this cash should market conditions warrant it.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

International

The MSCI All Country World Index declined -4.9% for the month of January, while the tech heavy Nasdaq declined -9.0%. The Nasdaq is now down -2.6% over six months and, as we write this in the first week of February, the declines have continued. Netflix and Tesla, poster children of tech's continued advance, have both plummeted from their recent highs earlier in the month, due to disappointing guidance to the market, and to fears that rising interest rates will depress growth valuations.

US CPI data for December came in at 7%, the fastest level in 40 years. This also means it's the 8th straight month where the rate is higher than 5%. In response, the Fed confirmed that they were indeed planning to hike rates in March. Chairman Powell also indicated that there was quite a bit of room to raise rates before it would start to hurt the economy.

Markets remained on tenterhooks over the possibility of a Russian invasion of Ukraine, while diplomats continued their frantic negotiations in the hope of avoiding war. The US economy lost momentum with the US Economic Surprise Index (ESI) falling below zero versus a Chinese economy which saw positive revisions and an acceleration in its ESI, moving above zero.

Commodity prices were strong led by Brent up \$13.5 to \$91/bbl (oil's best month since 2009). Iron ore rose \$19.3 to \$125.4/ton, while PGMs also gained with Palladium +24% and Rhodium +19% as auto production gained steam.

South Africa

The All Share Index returned 0.9% for the month of January, with the Rand strengthening 3.5% versus the Dollar. Bonds underperformed with the ALBI grinding higher (+0.8%).

A strong performance by the mining sector further boosted corporate tax receipts in December, resulting in a fiscal deficit that is now forecast to compress to 5.4% in FY21/22 (vs. -6.6% in the Medium Term Budget Statement; -9.9% in FY21).

The sweet spot in SA equities of rising commodities and a resilient rand has resulted in a solid performance from both domestics and offshore stocks. PGM's have held up strongly with the price basket up +11.3% YTD, signaling a recovery from a weak second half of last year and with the rand now the 4th best performing currency in EM the universe. At its January MPC meeting, the SA Reserve Bank delivered on the expected 25bp tightening but, contrary to expectations, not all MPC members were in favor of a hike.

Investment Policy

The Flagship IP Worldwide Flexible Fund of Funds is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the portfolio is to offer medium to long-term capital growth. The portfolio will invest in a range of participatory interests in equity, bond, money or property markets, in portfolios of collective investment schemes.

In order to achieve its objective, the investments normally to be included in the Flagship IP Worldwide Flexible Fund of Funds will, apart from assets in liquid form, consist of participatory interests of portfolios of collective investment schemes or other similar schemes, in equity, bond, money or property markets, registered in the Republic of South Africa, or of portfolios of collective investment schemes or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee, and comply with the requirements of the Act and any regulations thereto.

TER and Transaction Costs

From 1 October 2018 to 30 September 2021 2.17% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.18% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.35% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.
