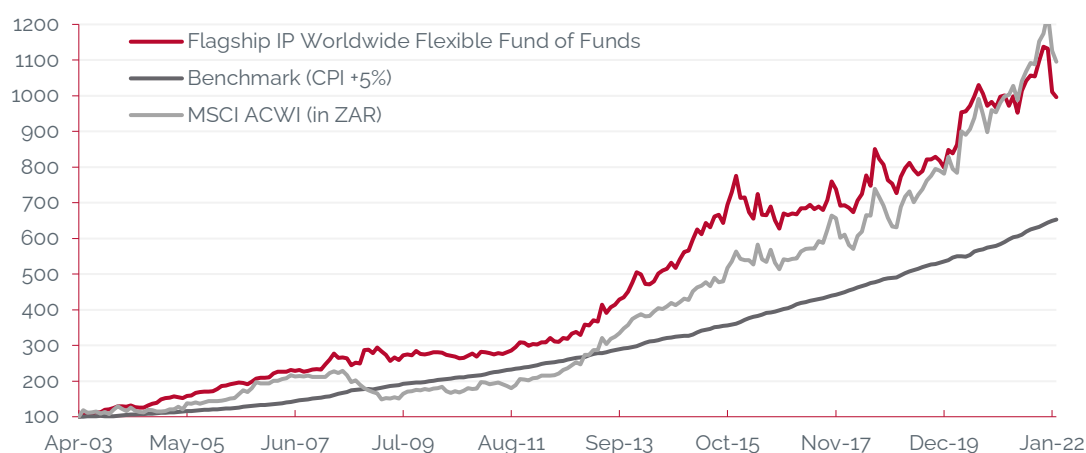

## FUND OBJECTIVE

The objective of the Flagship IP Worldwide Flexible Fund of Funds is to deliver long term capital growth by investing in a focused portfolio of stringently selected global equity fund managers. Investments, on a see-through basis, will be diversified across geographic regions, in both developed and emerging markets, and diversifies single manager and single style risk associated with investing through one asset manager only. The fund may invest across all asset classes, but, through the cycle, equity exposure will be maintained at around 80%, with the objective to outperform the MSCI World Index (in rands) over the long term (5 years). Our formal benchmark is CPI +5% and the fund is classified in the Worldwide - Multi Asset - Flexible sector.

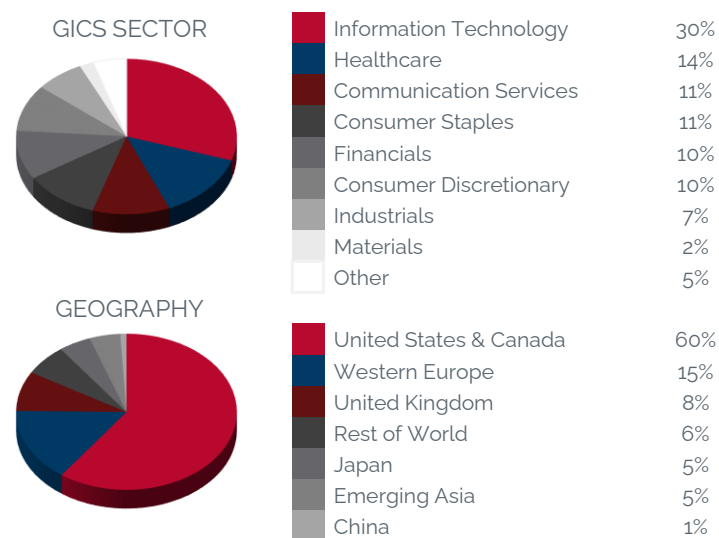

## FUND COMMENTARY - FEBRUARY 2022

The Flagship IP Worldwide Flexible Fund of Funds -1.6% in ZAR as the volatile conditions that have dominated global markets of late continued in February.

Guinness Global was the biggest detractor for the month, while the best performer was the iShares World Value fund, which managed to stay flat in turbulent market conditions that left most funds under water.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

## MARKET COMMENTARY

### International

It's been a tumultuous month on the global stage, and subsequently in global markets. From Boris Johnson's COVID indiscretions, to a marred-by-controversy Beijing Winter Olympics, culminating in a full scale Russian military invasion of Ukraine.

Both the S&P 500 and Nasdaq indices were down more than 3% in February and are now down 8% and 12% respectively year-to-date. The MSCI ACWI fared only slightly better, falling 2.5% during the month, and 7.3% year-to-date.

Safe haven assets understandably rallied during the volatility, with the price of Brent Crude climbing another 10% during the month to hit \$100 dollars/barrel. (At the time of writing it spiked to more than \$115/barrel – its highest level since 2014.) It is now up more than 30% this year. Gold also enjoyed a very strong month, trading 6.2% higher at month end.

International condemnation of Russia's invasion has been swift, with the West imposing its toughest sanctions yet on Russia, including freezing of its vast foreign reserves. This has led to some of Russia's largest companies shedding more than 95% of their market capitalization during the month, and

the Russian Rouble losing more than 30% of its value versus the US Dollar. Large multinationals like BP, ExxonMobil and Apple have all indicated they are halting operations and investments in the country, while Norges, the world's largest Sovereign Wealth Fund, has indicated they will start divesting completely from Russia.

The US CPI number came in at 7.5% in February, the highest level in 40 years. While the conflict could hamper economic recovery, the Federal Reserve has indicated that it plans to move ahead with the first planned rate hike of the year in March.

### South Africa

The ZAR was flat against the dollar during February but is 3.5% stronger year-to-date. The JSE All Share index was one of the few global indices in the green this month, rising 3.2%, driven by the JSE Resources Index which rallied 16% higher given the global resource concerns amid the ongoing Russian invasion.

Finance Minister Enoch Godongwana's budget speech was largely viewed in a positive light, with corporate tax rates being reduced by a percentage point in the hope of attracting more foreign investors.

- SARS requires us to pay over Dividend Withholding Tax (DWT) on your behalf where applicable. We will deduct this tax before we pay any dividends to you or reinvest into your account. Unless we receive information from you indicating otherwise, we will be obliged to withhold the default DWT of 20%.
- The EAC is a standard industry measure which has been introduced to allow you to compare the charges you incur and their impact on the investment returns over specific periods. ## Investment Policy

The Flagship IP Worldwide Flexible Fund of Funds is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the portfolio is to offer medium to long-term capital growth. The portfolio will invest in a range of participatory interests in equity, bond, money or property markets, in portfolios of collective investment schemes.

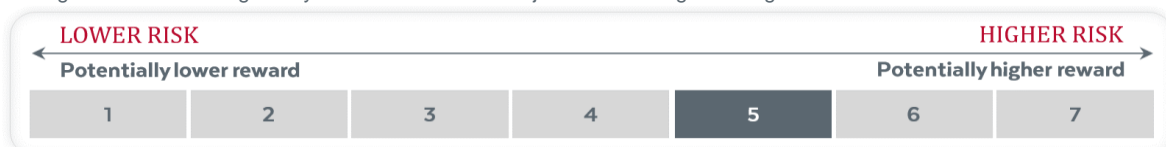
In order to achieve its objective, the investments normally to be included in the Flagship IP Worldwide Flexible Fund of Funds will, apart from assets in liquid form, consist of participatory interests of portfolios of collective investment schemes or other similar schemes, in equity, bond, money or property markets, registered in the Republic of South Africa, or of portfolios of collective investment schemes or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee, and comply with the requirements of the Act and any regulations thereto.

## TER and Transaction Costs

From 1 January 2019 to 31 December 2021 2.19% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.12% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.31% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.

The use of several managers diversifies the single-manager and single-style risk associated with investing through one asset manager only. Asset allocation is adjusted according to changes in market conditions..
