

#### **FUND OBJECTIVE**


To provide long term capital growth from an actively managed portfolio comprising equities, bonds, listed property and cash - both local and foreign. To achieve long term capital growth, the fund will have a bias towards equity (which typically offers the best returns over the long run), but no guidelines have been set for maximum and minimum exposures to any one asset class. Our benchmark is 60% equities, 20% bonds and 20% cash with each category split equally between local and international assets. The fund is classified with ASISA as a Worldwide - Multi Asset -Flexible fund.

# FUND COMMENTARY - NOVEMBER 2023

The Flagship IP Worldwide Flexible Fund returned 3.8% vs its composite benchmark which was up 6.9% (both in ZAR), as equity and bond markets experienced a particularly strong start to the Santa rally.

The biggest contributors for the month were Endava and Stone, while the main detractors were Alibaba and Schlumberger. During the month, we entered new positions in Stone, Expedia, Petrobras, Jumbo and Rolls Royce, while closing positions in Endava and Credicorp.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

#### **MARKET COMMENTARY**

Stocks were early to the Santa-rally this year, with most major indices. Both countries were looking to ease relations which have been tense in recent delivering strong returns for the month. In the US, the S&P 500 and Nasdag returned 9.1% and 10.8% respectively. Across the pond, London's FTSE 100 returned 2.3% while further East Japan's Nikkei 225 also had a strong month, regards Xi to be a dictator, so they probably aren't pen pals just yet. returning 8.5%. Positive returns were not limited to equities, as US Bond prices also staged a recovery during the month. The yield on 10- and 30-year government bond yields declined by 12.2% and 11.8% respectively, as traders bought up high-yielding bonds in a bet that interest rates will start falling sooner rather than later.

Much of the strong performance can be attributed to US CPI numbers coming in slightly softer than expected, and the market again raising its hopes that a soft landing is indeed possible. Worrying signs remain, however, as large forces behind gold, which reached all-time highs in early December '23.

#### **Investment Policy**

The Flagship IP Worldwide Flexible Fund is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the Flagship IP Worldwide Flexible Fund is to offer medium to longterm capital growth. The portfolio will invest in a flexible combination of investments in equity, bond, money or property markets to maximise total returns over the long term. The portfolio will be actively managed with exposure to various asset classes being varied to reflect changing economic and market circumstances, in order to maximise returns for investors.

In order to achieve its objective, the investments normally included in the Flagship IP Worldwide Flexible Fund will comprise a combination of local and foreign securities, exchange securities, stock including loan stock, financially sound listed property investments and participatory interests in portfolios of collective investment schemes in property shares, assets in liquid form and any other securities which are considered consistent with the portfolio's primary objective and the Act or the Registrar may from time to time allow, all to be acquired at fair market value. To the extent permitted by legislation, the fund may use exchange traded funds and financial instruments to implement specific investment views.

#### **TER and Transaction Costs**

From 1 October 2020 to 30 September 2023 2.18% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.41% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.59% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.
