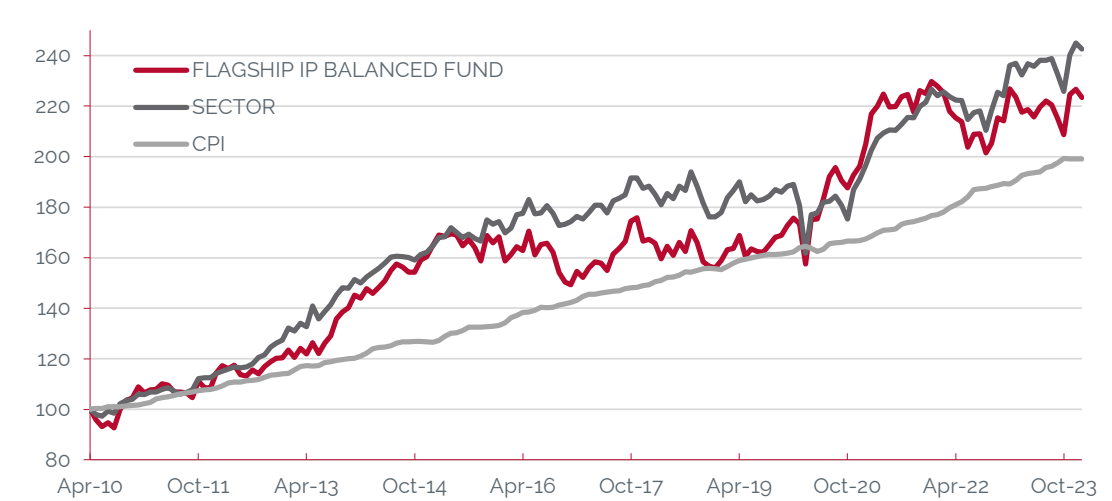

## FUND OBJECTIVE

The objective of the Flagship IP Balanced Fund is to seek steady growth of both capital and income through investments in a broad range of asset classes in a balanced manner. This Regulation 28 managed fund is classified as South African - Multi Asset - High Equity and aims to maximize returns over the medium to long term utilising flexible asset allocation strategies taking active decisions in accordance with current and projected economic and market conditions. The fund invests in equities, bonds, property and money market and is restricted to maximum limits in accordance with prudential regulations which, inter alia, provide that equity, held both locally and abroad, will not exceed 75% of the fund and offshore investment is restricted to 30% of the fund. Out-performance is targeted through aggressive asset allocation and focused stock selection based on in-house proprietary models and extensive internal and external research. The portfolio uses financial instruments only to the extent permitted by legislation.

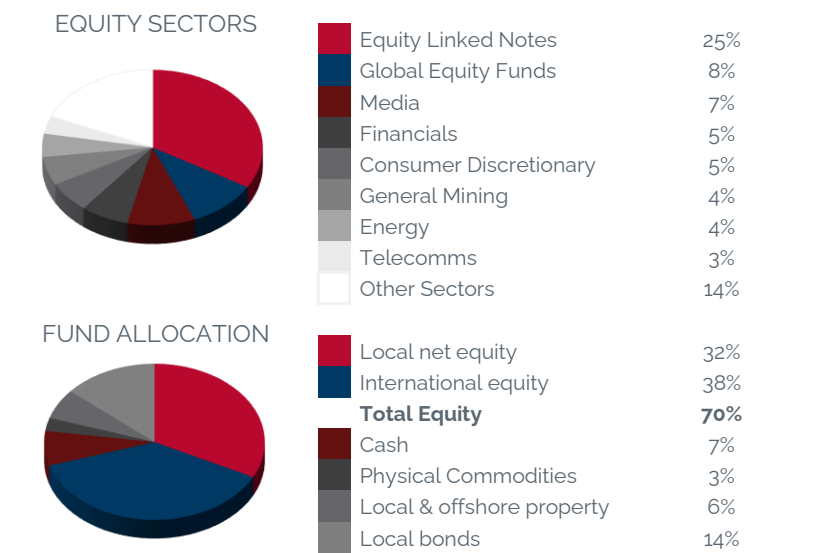

## FUND COMMENTARY - JANUARY 2024

The Flagship IP Balanced Fund returned -1.5% over the month, below the fund's benchmark sector average of -1.0%, but ahead of the JSE's 3.0% fall.

The fund benefitted from healthy gains in three of the fund's larger holdings – Richemont (+9.7%), Mr Price (+9.3%), and Bidcorp (+6.4%) , but the 17.3% fall in MTN (on the back of a plummeting Naira) and weakness in resource index counters Mondi (-15.6%), Sasol (-11.4%) and Glencore (-9.7%), detracted from fund returns.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

After ending 2023 on a strong note, global equity indices delivered a mixed start to 2024. In the US, both the S&P 500 and Nasdaq improved by 1.7% and 1.0% respectively. The Russell 2000 had a tough start to the year, though, dropping by 3.9%. In the UK, the FTSE 100 fell 1.3%, while in the Asia there were vastly different results on opposite sides of the East China Sea. Japan's Nikkei gained 8.4%, while Hong Kong's Hang Seng lost 9.2%.

The latest US CPI reading showed an uptick, increasing by 3.4% on a year-over-year basis (forecast at 3.2% and December at 3.1%), contributing to the Fed's more cautious commentary on the prospects of near-term rate cuts. January has delivered some signs of weakness in the job market, though, with UPS alone announcing 12,000 job cuts. The Fed continues its tightrope balancing act between taming inflation and maximum employment.

In US politics, the race for the top 2 Republican nominees is as good as done. Donald Trump started the primaries strongly, winning both Iowa and New Hampshire. This led to his main rival, Florida Governor Ron deSantis, dropping out very early in the race, and almost guaranteeing Trump the position of Republican nominee. Reports have emerged that Trump is targeting a massive trade war with China if re-elected as president. This would obviously cause ripple effects across global markets.

The US is one of more than 50 countries holding elections this year – in what is being billed as one of the biggest election years in history. Taiwan kicked off the year with a victory for the pro-democracy (and thus anti-China) party, representing another blow to the struggling Chinese economy, which is reeling from its property sector crisis and rising unemployment. The ruling Communist Party have tried a number of approaches to stem the subsequent bleeding in its stock market, but these efforts have largely failed.

South African investors experienced a red month to start the year. The All Share lost 2.9%, the Resources index dropped 6.3%, and the Rand weakened 1.8% against the US Dollar.

The year ahead will almost certainly be dominated by the looming general election – potentially a pivotal year in South Africa's history. The ANC, after more than 30 years in power, faces the real possibility of losing their majority, as the party continues to be plagued by corruption, maladministration, and internal power struggles. This would open the door for a number of different coalition scenarios. In what promises to be the first of many, the looming election has already produced its first shake up – as former president Jacob Zuma was officially suspended from the ANC after backing the newly formed MK party. Perhaps this is a sign of things to come for the governing party...

Investment Policy

The Flagship IP Balanced Fund is to be a domestic, asset-allocation, prudential variable portfolio. The primary objective of the fund is to seek steady but stable growth of both capital and income through investments in a broad range of asset classes in a balanced manner. In order to achieve its objective, the investments normally to be included will comprise a combination of securities in the equity, bond, property and money markets. The portfolio will have an equity exposure (including international equity) between 0% and 75% at all times. Investments to be included in the Flagship IP Balanced Fund will comprise a combination of securities and assets in liquid form which are considered consistent with the portfolio's primary objective and that the Act or the Registrar may from time to time allow, all to be acquired at fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes registered in South Africa or operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee and as legislation permits. Nothing contained in the investment policy shall preclude the manager from varying the ratio of the aforementioned securities relative to each other (except as required by the Act), or the assets themselves, to maximise capital growth and investment potential, should changing economic factors or market conditions so demand. Provided also that nothing contained in the investment policy shall preclude the Manager from retaining cash in the portfolio and / or placing cash on deposit in terms of the deed. Provided further that the Manager shall ensure that the portfolio includes securities and assets in liquid form, of at least the aggregate value required, from time to time, by the Act. The Manager will be permitted to invest on behalf of the portfolio in offshore investments as legislation permits. The Manager will be permitted to invest on behalf of the portfolio in financial instruments as legislation permits. The portfolio will be managed so as to comply with prudential requirements with which a pension fund investment strategy must comply in terms of applicable legislation. For the purpose of this portfolio, the manager shall reserve the right to close the portfolio to new investors on a date determined by the manager. This will be done in order to be able to manage the fund in accordance with its mandate. The manager may, once a portfolio has been closed, open that portfolio again to new investors on a date determined by the manager.

TER and Transaction Costs

From 1 October 2020 to 30 September 2023 2.18% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.25% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.43% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.
