

FUND OBJECTIVE

The Flagship IP Flexible Value Fund aims to outperform both the JSE All Share Index and competing funds over the medium to long term. We rely on fundamental research to identify investments which are trading at a discount to their intrinsic value and to determine which asset classes are the most attractive. The fund will typically have a very different equity profile from that of the All Share Index. Risk is reduced through the fund's value oriented approach.

FUND COMMENTARY ~ JANUARY 2024

The fund held up relatively well in January, thanks to a resilient performance from domestic small cap shares which comprise a large portion of the portfolio. In this regard, Frontier Transport was the standout performer. The shares rose 13% over the month on the back of a sizable and unexpected special dividend announcement. Post the dividend, this well managed company remains cash flush and we expect to retain a meaningful holding. Another of the fund's larger investments – printing and packaging group Novus – also announced a special dividend and the shares rose further, having already had a strong run over the last few months. On the negative side, our offshore equities held via Contrarius Global Equity Fund had a poor month, dragged down by Tesla's 25% fall in January. This was initially on the back of negative Elon Musk news flow and later in the month exacerbated by disappointing results and a weak outlook statement. Warner Brothers Discovery and Weight Watchers International were two other detractors.

MARKET COMMENTARY

start to 2024. In the US, both the S&P 500 and Nasdaq improved by 1.7% and 1.0% respectively. The Russell 2000 had a tough start to the year. though, dropping by 3.9%. In the UK, the FTSE 100 fell 1.3%, while in the Asia there were vastly different results on opposite sides of the East China Sea. Japan's Nikkei gained 8.4%, while Hong Kong's Hang Seng lost 9.2%.

The latest US CPI reading showed an uptick, increasing by 3.4% on a yearover-year basis (forecast at 3.2% and December at 3.1%), contributing to the Fed's more cautious commentary on the prospects of near-term rate cuts. January has delivered some signs of weakness in the job market, though, with UPS alone announcing 12,000 job cuts. The Fed continues its tightrope balancing act between taming inflation and maximum employment.

In US politics, the race for the top 2 Republican nominees is as good as done. Donald Trump started the primaries strongly, winning both Iowa and New Hampshire. This led to his main rival, Florida Governor Ron deSantis, dropping out very early in the race, and almost guaranteeing Trump the position of ripple effects across global markets.

After ending 2023 on a strong note, global equity indices delivered a mixed The US is one of more than 50 countries holding elections this year – in what is being billed as one of the biggest election years in history. Taiwan kicked off the year with a victory for the pro-democracy (and thus anti-China) party, representing another blow to the struggling Chinese economy, which is reeling from its property sector crisis and rising unemployment. The ruling Communist Party have tried a number of approaches to stem the subsequent bleeding in its stock market, but these efforts have largely failed.

> South African investors experienced a red month to start the year. The All Share lost 2.9%, the Resources index dropped 6.3%. and the Rand weakened 1.8% against the US Dollar.

The year ahead will almost certainly be dominated by the looming general election - potentially a pivotal year in South Africa's history. The ANC, after more than 30 years in power, faces the real possibility of losing their majority, as the party continues to be plagued by corruption, maladministration, and internal power struggles. This would open the door for a number of different coalition scenarios. In what promises to be the first of many, the looming Republican nominee. Reports have emerged that Trump is targeting a massive election has already produced its first shake up – as former president Jacob trade war with China if re-elected as president. This would obviously cause Zuma was officially suspended from the ANC after backing the newly formed MK party. Perhaps this is a sign of things to come for the governing party...

Investment Policy

The Flagship IP Flexible Value Fund is an asset allocation portfolio. The manager, in selecting securities for the portfolio, will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Flagship IP Flexible Value Fund, shall comprise a mix of securities, which may include ordinary shares, preference shares, debentures, fixed interest instruments, gilts and money market instruments as defined in the Act and the Deed, all to be acquired at a fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes or other similar schemes. Where the aforementioned schemes are operated in territories other than in South Africa, participatory interests or any other form of participation in these schemes will be included in the portfolio only where the regulatory environment is to the satisfaction of the manager and trustee and is of sufficient standard to provide investor protection at least equivalent to that in South Africa. The portfolio is permitted to invest in financial instruments in line with the conditions by the Registrar from time to time.

TER and Transaction Costs

From 1 October 2020 to 30 September 2023, 1.80% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.26% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore 2.06% of the value of the fund was incurred as costs relating to the investment of the fund. Inclusive in the TER of 1.80%, a performance fee of 0% of the Net Asset Value of the class of Financial Product was recovered. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns.
