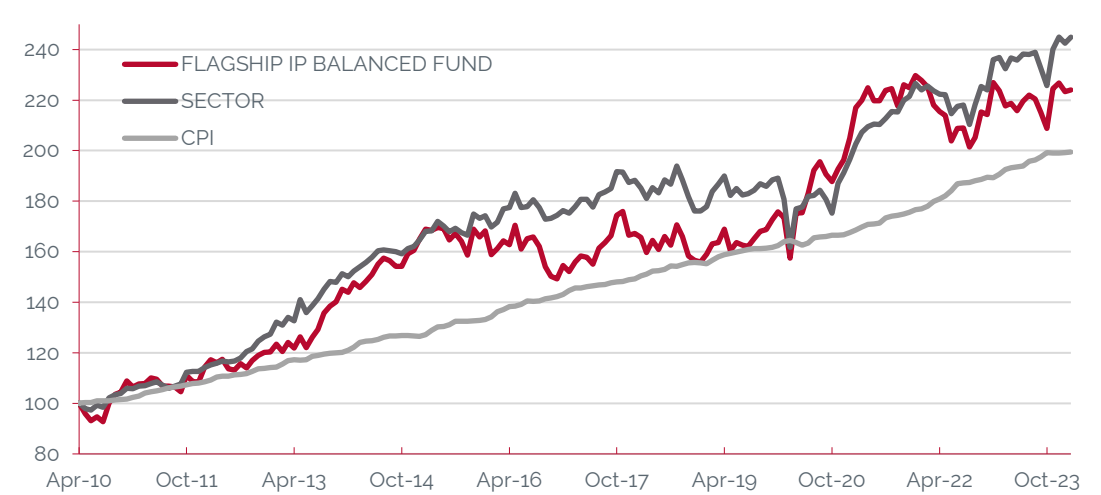

## FUND OBJECTIVE

The objective of the Flagship IP Balanced Fund is to seek steady growth of both capital and income through investments in a broad range of asset classes in a balanced manner. This Regulation 28 managed fund is classified as South African - Multi Asset - High Equity and aims to maximize returns over the medium to long term utilising flexible asset allocation strategies taking active decisions in accordance with current and projected economic and market conditions. The fund invests in equities, bonds, property and money market and is restricted to maximum limits in accordance with prudential regulations which, inter alia, provide that equity, held both locally and abroad, will not exceed 75% of the fund and offshore investment is restricted to 30% of the fund. Out-performance is targeted through aggressive asset allocation and focused stock selection based on in-house proprietary models and extensive internal and external research. The portfolio uses financial instruments only to the extent permitted by legislation.

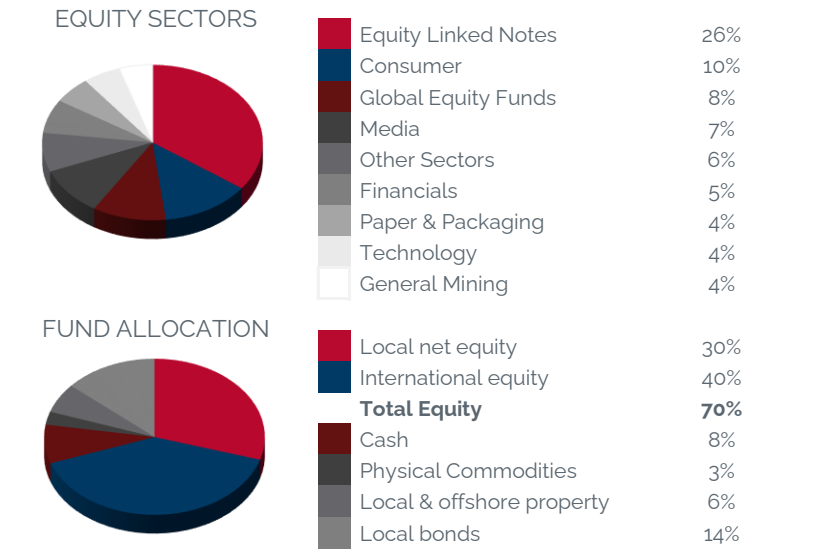

## FUND COMMENTARY - FEBRUARY 2024

The Flagship IP Balanced Fund returned 0.3% over the month, behind the sector average benchmark of 1.0%, but well ahead of the poor return from the JSE Allshare at -2.4%. Solid performance from Richemont (+8.9%) and NEPI Rockcastle (+8.5) contributed to the fund's positive return, but performance was hampered by very poor returns from Sasol (-11.9%) and MTN (-12.6%). During the month we increased our holding in Sasol as we believe chemical prices are near their lows and operational performance from the company was better than expected. The company trades on low single digit Price-to-Earnings and Price-to-EBITDA multiples, at more than a 50% discount to its global peers. MTN, however, was sold mid-month as the Nigerian currency's rapid devaluation has continued aggressively since financial year end (-55% year-to-date), severely impacting MTN Nigeria' and the Group's earnings over the next six months. As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

Global equity markets delivered yet another strong showing during February. In the US, the S&P 500, Russell 2000 and Nasdaq composite all gained more than 5%. UK markets were more muted, with the FTSE 100 returning 0.5%. Performance in the East was strong, with Japan's Nikkei returning 8%, and even Hong Kong ended the month almost 7% higher.

The Nikkei's strong performance was despite the Japanese economy slipping into an unexpected technical recession, driven mainly by weaker than expected domestic consumption numbers. This also means that Germany has now overtaken Japan to become the world's 3<sup>rd</sup> largest economy.

There should be little doubt that these returns continue to be fuelled by big tech and the expected advantages brought about by AI. Few earnings events were watched as closely as that of Nvidia, which delivered another big beat along with increased guidance, leading the S&P to a new all-time-high. Shortly before this, stocks in the US experienced a brief speedbump as January's CPI reading came in slightly higher than expected, in stark contrast with China as their CPI numbers again came in lower than expected and PPI numbers have now been in deflationary territory for 16 months in a row.

Across the globe, geopolitical tensions continue to simmer. Russia's war in

Ukraine has reached a grim 2-year milestone, and we seem to be no closer to its end. In fact, the prevailing narrative seems to be one of escalating tensions rather than decreasing. Talks of NATO potentially sending soldiers onto Ukrainian soil were met with threats of nuclear warfare by the Kremlin. The Kremlin again showed its hand when its biggest political threat, Alexei Navalny, died suddenly in a Siberian penal colony. All of this has cast a new light on European and NATO military budgets, especially with odds increasing that Donald Trump could once again be elected US president later this year.

Locally, investors were not able to partake in the global market euphoria in February, as was the case in 2023. The JSE All Share index dropped by 2.4%, while the Resources index declined by almost 7%. Exacerbating these losses was the performance of the Rand, which declined by almost 3% against the USD over the course of the month.

The much-anticipated budget speech did not deliver a great deal of fireworks, with the main talking point being Government drawing R150 billion (of its total of R500 billion) from foreign gold and currency reserves as our budget deficit continues to grow. Lastly, Cyril Ramaphosa declared 29 May as the official election date. This promises to be a very insightful day into South Africa's future, as the ANC faces its biggest threat yet of being booted from power.

Investment Policy

The Flagship IP Balanced Fund is to be a domestic, asset-allocation, prudential variable portfolio. The primary objective of the fund is to seek steady but stable growth of both capital and income through investments in a broad range of asset classes in a balanced manner. In order to achieve its objective, the investments normally to be included will comprise a combination of securities in the equity, bond, property and money markets. The portfolio will have an equity exposure (including international equity) between 0% and 75% at all times. Investments to be included in the Flagship IP Balanced Fund will comprise a combination of securities and assets in liquid form which are considered consistent with the portfolio's primary objective and that the Act or the Registrar may from time to time allow, all to be acquired at fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes registered in South Africa or operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee and as legislation permits. Nothing contained in the investment policy shall preclude the manager from varying the ratio of the aforementioned securities relative to each other (except as required by the Act), or the assets themselves, to maximise capital growth and investment potential, should changing economic factors or market conditions so demand. Provided also that nothing contained in the investment policy shall preclude the Manager from retaining cash in the portfolio and / or placing cash on deposit in terms of the deed. Provided further that the Manager shall ensure that the portfolio includes securities and assets in liquid form, of at least the aggregate value required, from time to time, by the Act. The Manager will be permitted to invest on behalf of the portfolio in offshore investments as legislation permits. The Manager will be permitted to invest on behalf of the portfolio in financial instruments as legislation permits. The portfolio will be managed so as to comply with prudential requirements with which a pension fund investment strategy must comply in terms of applicable legislation. For the purpose of this portfolio, the manager shall reserve the right to close the portfolio to new investors on a date determined by the manager. This will be done in order to be able to manage the fund in accordance with its mandate. The manager may, once a portfolio has been closed, open that portfolio again to new investors on a date determined by the manager.

TER and Transaction Costs

From 1 January 2021 to 31 December 2023 2.20% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.21% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.41% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.
