

FUND OBJECTIVE

The objective of the Flagship IP Balanced Fund is to seek steady growth of both capital and income through investments in a broad range of asset classes in a balanced manner. This Regulation 28 managed fund is classified as South African - Multi Asset - High Equity and aims to maximize returns over the medium to long term utilising flexible asset allocation strategies taking active decisions in accordance with current and projected economic and market conditions. The fund invests in equities, bonds, property and money market and is restricted to maximum limits in accordance with prudential regulations which, inter alia, provide that equity, held both locally and abroad, will not exceed 75% of the fund and offshore investment is restricted to 30% of the fund. Out-performance is targeted through aggressive asset allocation and focused stock selection based on in-house proprietary models and extensive internal and external research. The portfolio uses financial instruments only to the extent permitted by legislation.

FUND COMMENTARY ~ JUNE 2024

The Flagship IP Balanced Fund returned 0.3% over the month, behind the fund's sector average benchmark of 1.1% and well below the JSE Allshare's 3.9% return. SA markets sagged initially in June after the ANC's weak performance at the 29 May national election raised fears that it would team up with the far-left EFF or MK party, but rallied sharply after the ANC announced it would form a Government of National Unity with the DA and a host of others. The fund benefitted from the surge in SA Inc counters with Financials up 14.5% (fund holdings Capitec +21.7%, Firstrand +18.3% and Standard Bank +16.5%) and General Retailers up 17.1% (Shoprite +12.8%, Clicks +9.9%). Performance was hampered by declines in the Resources index which fell 3.6% (Sappi -10.6%, Glencore -9.5%) and Technology -4.1% (Naspers -4.9%), together with another month of declines in the fund's China holdings (Invesco Golden Dragon ETF -13.8%, JD.com -13.7%). MARKET COMMENTARY

half of the year. In the US, all rooms were sea-facing as the S&P 500 returned 3.6% for the month, largely driven by constituents that also form part of the tech-heavy Nasdag composite which returned 6% for the month. Year-to-date (YTD), the S&P 500 has now returned 15.3%, while the Nasdag composite returned 18.6%. In the shadow of this tech-driven performance, we find the small cap Russell 2000 index, which was down 0.9% for the month, and is barely in the green, YTD. In the UK, the FTSE 100 dropped 1.7% for the month, while the Euro Stoxx 50 declined by almost 3%. YTD, both indices have returned in the region of 7%. In the East, the Hang Seng Index continues to be volatile. After a strong recovery the previous month, June saw it giving back 1.1%, which now puts the YTD performance at 6.2%.

Despite the robust stock market performance in the US, there are certainly some warning lights flickering. One of these is the weak breadth of the market rally. YTD, Nvidia (+166%) accounted for 6% of the S&P 500's 15% return, with the S&P 499 returned only 9%. Remove the rest of the Magnificent 7, and the return of the S&P 493 drops to 6% YTD. The second concern is consumer weakness – retail sales came in softer than expected in May, confirmed by profit warnings from several consumer driven sectors. Footwear and apparel giant Nike a clear example of this, falling 20% after providing weak guidance.

Global equity markets delivered vastly different results to close out the first Headlines in June were dominated by politics. A major political swing was confirmed in the UK, as the Conservative Party lost to Labour, after 14 years in power. In France, after a dominant showing by Marine le Pen's "Far right" National Rally in the first round of elections, circumstances changed dramatically in the second round, with a swing back to the centre and far left, leaving no party with an overall majority. In the US, a Republican (i.e., Donald Trump) victory is now looking likely after Joe Biden performed terribly in the first presidential debate. This raised the alarm in Democratic circles, as voters now believe his cognitive state is clearly not fit for someone occupying the most powerful office in the world.

> Locally, news flow was dominated by the bickering and bumping of heads between the DA and the ANC as President Ramaphosa tried to get his cabinet for the Government of National Unity up and running. After much debate, and the DA threatening to pull out of the agreement, a deal was finally struck which led to optimism in local markets, evident in the double-upgrade South Africa received from JP Morgan. Responding to improved sentiment, the JSE Allshare Index staged an impressive rally, returning 4.1% over the month, while the JSE Financials index surged an eye-popping 17.5%. This strong performance, if not given back, should lead to increased weighting in emerging market indices, which should lead to increased flows from international investors.

Investment Policy

The Flagship IP Balanced Fund is to be a domestic, asset-allocation, prudential variable portfolio. The primary objective of the fund is to seek steady but stable growth of both capital and income through investments in a broad range of asset classes in a balanced manner. In order to achieve its objective, the investments normally to be included will comprise a combination of securities in the equity, bond, property and money markets. The portfolio will have an equity exposure (including international equity) between 0% and 75% at all times. Investments to be included in the Flagship IP Balanced Fund will comprise a combination of securities and assets in liquid form which are considered consistent with the portfolio's primary objective and that the Act or the Registrar may from time to time allow, all to be acquired at fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes registered in South Africa or operated in territories with a regulatory environment which is to the satisfaction of the Manager and the Trustee and as legislation particular of the investment policy shall preclude the manager from varying the ratio of the aforementioned securities relation of the investment policy shall preclude the manager from varying the ratio of the aforementions of the investment policy shall preclude the manager from varying the ratio of the aggregate value required in the investment policy shall preclude the Manager shall ensure that the portfolio and / or placing cash on deposit in terms of the deed. TER and Transaction Costs

From 1 April 2021 to 31 March 2024 2.19% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.22% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.41% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.

The fund managers seek to reduce risk by investing in a range of assets diversified across sectors and geographies, with the flexibility to vary exposures as market circumstances dictate.
