

FUND OBJECTIVE


FUND MANAGER

FUND COMMENTARY - AUGUST 2024

The fund's 1.6% return in August was satisfactory, and was again driven by a good performance from our domestic small cap stocks: specifically two of them – Caxton and Brait. Caxton is the fund's largest holding and the shares gained 12% in August. We don't expect any fireworks from the company's imminent interim results, but the shares remain undervalued by any normal metrics, and the market has warmed to the fact that Peregrine Capital have recently been large buyers of the shares, while Allan Gray's relentless selling over the past few years must be coming to an end with their stake now below 5%. As for Brait, the company completed it's R1.5bn rights issue in early August and investors have reacted very positively to the strengthened balance sheet and rewarded the shares accordingly, with a strong price gain post rights issue. Brait was a sub 2% position at end July, but this has moved up to 5.7% (see table above right) through the combined effect of taking up all the fund's rights along with a meaningful share price advance during the month. As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

MARKET COMMENTARY

After a fairly volatile July, the start of August saw more of the same, before relative calm returned to markets late in the month. The US unemployment rate climbing for the 4th month in a row sent markets into freefall over fears that the Fed might have left interest rates too high, for too long - effectively steering the economy into a recession. These fears proved temporary, though, and markets clawed back some of the losses. At month end, the S&P 500 had rallied to gain 2.4% for the month, outpacing its tech-heavy Nasdaq peer, which return 0.7%. The small-cap Russell 2000 declined, giving up 1.5% during the month. In Europe, the Stoxx 50 gained 2.4%, while London's FTSE 100 advanced by 0.8%. Indices in the East were mixed, with Japan's Nikkei losing 1.1%, while the Hang Seng index had a strong month, returning 3.9%.

CPI numbers in the US came in below 3% for the first time in nearly 3.5 years. This, along with a downward revision of jobs data, basically guaranteed rate cuts were on the way, and all eyes turned to the Fed's Jackson Hole symposium where Chairman Jerome Powell delivered the strongest confirmation yet that borrowing rates would be reduced at the next Federal Reserve meeting in September.

On the geopolitical front, the situation in the Middle East remains tense after Iran vowed retaliation against Israel after a political assassination, prompting events revealing the factions and infighting in local politics.

the US to send an aircraft carrier and submarines to the region. Russia received somewhat of a bloody nose as Putin was forced to divert troops from his Ukrainian invasion back to Russia to defend the motherland after Ukraine made strong advances in their counter-attack in the Kursk region. Putin and the Kremlin were outraged, calling it a major provocation. Quite rich.

The ongoing global conflicts, coupled with US debt breaching \$35 trillion, meant investors still sought out safety in gold. The metal hit several record highs during the month, gaining 3.8% and closing above \$2,500 per ounce. This means one standard bar of gold is now worth more than \$1 million.

Local investors experienced another strong month with the JSE All Share index gaining 1.4%. while the financials index gained 5.3%. Resources had a tough month, though, closing down 10.2%. The Rand also had a strong month, gaining 2.8% against the dollar. The Rand is now more than 7% stronger over the last 6 months. Consumers also received some good news, as local inflation surprised on the downside, coming in at 4.6%, its lowest level since 2021.

In local politics, Floyd Shivambu caused a stir, ditching the EFF and longtime ally Julius Malema, for Jacob Zuma's MK Party, the latest in a long line of

Investment Policy

The Flagship IP Flexible Value Fund is an asset allocation portfolio. The manager, in selecting securities for the portfolio, will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives the investments to be acquired for the Flagship IP Flexible Value Fund, shall comprise a mix of securities, which may include ordinary shares, preference shares, debentures, fixed interest instruments, gilts and money market instruments as defined in the Act and the Deed, all to be acquired at a fair market value. The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes or other similar schemes. Where the aforementioned schemes are operated in territories other than in South Africa, participatory interests or any other form of participation in these schemes will be included in the portfolio only where the regulatory environment is to the satisfaction of the manager and trustee and is of sufficient standard to provide investor protection at least equivalent to that in South Africa. The portfolio is permitted to invest in financial instruments in line with the conditions by the Registrar from time to time.

TER and Transaction Costs

From 1 July 2021 to 30 June 2024, 1.70% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.27% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore 1.97% of the value of the fund was incurred as costs relating to the investment of the fund. Inclusive in the TER of 1.70%, a performance fee of 0% of the Net Asset Value of the class of Financial Product was recovered.
